The meeting of BOS members of Human Science and Clinical Psychology [MSc] was conducted on 19/04/2023 from 2:00 PM onwards in IT department; lab number:2. The meeting was conducted to update T. Y. BSc [H.S] and M.Sc clinical psychology [semester 3 and 4] syllabus. A new Certificate course ie; "Introduction to Ornithology" was also discussed to be launch in upcoming academic year ie; 2023-24. The syllabus related to the course was also finalized during the meeting.

Following Changes were suggested by the members of BOS during the meeting: [Dr. Neeta Mehta].

For M.Sc. Clinical Psychology

1. Instead of 3 units, 4 Units should be added to each papers but in the entire college, PG Courses has 3 Units with 20 Lectures per unit for uniformity we kept 3 unit itself
2. The outcome of the course will be written with each paper using action words [verbs]
3. In Semester 3 Paper one unit one of Family theories added.
4. Anxiety disorders, schizophrenia with mood disorder and eating disorder in paper I is added
5. In paper II; heading of unit 1 and unit 2 are suggested to be changed into Introduction to study of brain and neurological assessment and interpretation and structural and functional unit of brain respectively.
6. In paper III: heading unit one should be changed to Introduction in the clinical assessment and also mention clinical scale version.
7. In paper 4 in unit 2 cognitive and behavioural theory and in unit 3 sociocultural theories with diagnostic personality disorder and definition; what is personality disorder controversy and categorization is added.
8. No changes were mentioned in paper IV.
9. In semester 4 Paper I; it was suggested that 20 lectures are not required to complete the unit and also addition of ethical guidance i.e., guidelines and therapy Skills. Also system theory, family perspective, post modern theory and narrative.



10. In paper II combine unit 1 and unit 2 and divide unit 3.

11. In paper III some specific changes were made i.e., the health policy and legal issues from unit 3 to be shifted to Unit 1. Child psychology is to be added in detail few changes in neurodevelopmental disorders were suggested and they are added.

12. In paper IV; removal of violent sexual offences [crime] and addition of treatment to anger and violence.

For T.Y. B.Sc. Human Science.

1. Course outcome should have action verbs [words]

2. Exposures cannot be used as course outcomes.

3. Addition of years and place with publishers in reference section i.e.; APS style of reference should be added. The necessary changes were done in meeting in the syllabus [incorporated]



After reviewing the syllabus, the meeting was adjourned anonymously.


