Minute of the meeting

1. Criteria 2:

Meeting was started from criteria 2, all CIA and regular examination results, the audit report of slow and advance learners was checked along with teaching learning tools used by the teachers for the year of 2020-21 by the coordinator. Coordinator suggested to criteria incharge regarding checking of admission data once again and asked to submit hard copy of evidences after corrections
