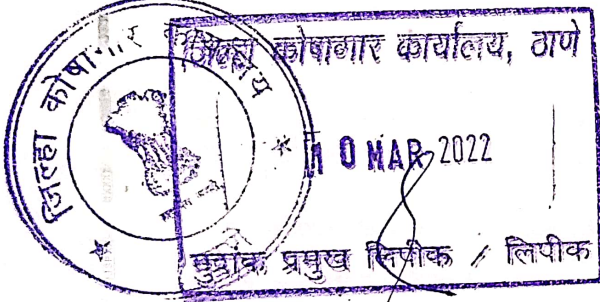

MEMORANDUM OF UNDERSTANDING (MoU)

Budokan Institute of Martial Arts

This MoU is entered into on the Seventh day of April 2022 by and between VPM's B. N. Bandodkar College of Science (Autonomous) (hereinafter called BNBCS), Thane, and Budokan Institute of Martial Arts, Thane (hereinafter called BIMA) situated at Thane in Maharashtra

The aforesaid Institutes are hereinafter referred to individually as institute and collectively as Institutes.

1. Objectives of MoU:

The objectives of MoU are:

- a) To promote and enhance mutual cooperation of Academic and Sporting Interest between BNBCS and BIMA.
- b) To provide advice and inputs for enhancement of quality of education and sports at BNBCS.
- c) To jointly contribute towards uplifting the status and quality of education and Sports.
- d) To promote co-curricular and extra-curricular activities between institutes.
- e) To make joint efforts to spread awareness on importance of sports, physical and mental wellness, hygiene and sanitation.
- f) To motivate learners and keep them in a high state of morale and confidence.

2. Technical areas of collaboration:

- a) Provide curricular, co-curricular and extra-curricular interaction by delivering invited lectures at BNBCS on relevant topics in academics and sports.
- b) Provide academic and co-curricular interaction in NCC, DLLE and NSS.
- c) Organizing training in life skills/ self defence.
- d) Cooperate in activities for mutual benefit of institutes wherever possible.
- e) To facilitate training for students and provide opportunities for participation.
- f) Offer guidance for enhancement in qualitative development of students.

3. Proposed modes of collaboration:

BNBCS and BIMA jointly propose to collaborate through the following:

- a) Co-operation and promotion of education and training in areas of mutual interests.
- b) Any other appropriate modes of interaction agreed upon between both institutes.
- c) A specific plan may be worked out by the MoU partners depending upon requirement and availability of resources.

4. Terms and Conditions:

- a) For continuing education to teachers and students, financial arrangements will be made as per mutually agreed terms.
- b) BNBCS proposes to motivate students for participating in training related to self defence, and general wellness conducted by BIMA for students of BNBCS.
- c) BIMA proposes to carry out training on self defence and general wellness for students and staff of BNBCS in BNBCS or Jnanadweep campus at mutually decided and subsidized amount.
- d) Usage of infrastructure for training can be allowed for limited period subject to availability, approval of head of Institution and Institute norms.
- e) This MoU may be amended, renewed and terminated by mutual written agreement of the Institutes at any time.
- f) Either institute shall have the right to terminate this MoU upon 60 days prior written notice to the other institute.

- g) On mutual consent of both the institutes review meetings will be conducted once in six months with co-coordinators/ signing authorities/ their representatives.

5. **Confidentiality:**

- a) The Institutes agree to hold in confidence all information/data designated by the Institutes as being confidential which is obtained from either Institute or created during the performance of the MoU and will not disclose the same to any third party without written consent of the other Institute.
- b) The above confidential clause under this MoU excludes the information/data possessed by either Institute before entering into the MoU or independently developed and/or information already available through public domain.

6. **Duration of MoU:**

This MOU, unless extended by mutual written consent of the Institutes, shall expire in **Two Years** after the effective date specified in the opening paragraph. However, on review, the MOU shall be extended by mutual consent.

7. **Coordinators:**

Both Institutes will designate persons who will have responsibility for co-ordination and implementation of this agreement.


8. **Intellectual Property Rights:**


The Intellectual Property Rights(IPR) that may arise as a result of joint research and collaborative activity under the agreement will be worked out on a case to case basis and will be consistent with officially laid down IPR policies of the two institutes.


9. **Signed in Duplicate:**

This MoU is executed in duplicate with each copy being an official version and having equal validity. By signing below, the MoU partners, acting by their duly authorized officers, have caused this Memorandum of Understanding to be executed, effective as of the day and year first above written.
