MEMORANDUM OF UNDERSTANDING (MoU)

This MoU is entered into on the Third day of 28<sup>th</sup> March 2022 by and between B.N. Bandodkar College of Science (Autonomous) (hereinafter called BNBCS), Thane, and E Incarnation Recycling Pvt Ltd. (hereinafter called EIRPL), Mumbai, a company active in protection of the environment through Recycling of E Wastes.

The aforesaid Institutes are hereinafter referred to individually as institution and collectively as Institutions.

## 1. Objectives of MoU:

The objectives of MoU are:

- a) To promote and enhance mutual cooperation of Environmental Interest between BNBCS and EIRPL.
- b) To provide advice for enhancement of quality of environmental education at BNBCS and allied institutes.
- c) To jointly contribute towards protection of the environment and its betterment through recycling of E-wastes.
- d) To have workforce of faculty and students aware about environmental pollution.
- e) To ensure the contribution of students towards environment.

## 2. Technical areas of collaboration:

- a) Provide interaction between BNBCS and EIRPL
- b) Provide necessary help and collaborations wherever applicable in organizing awareness lectures/ seminars/ workshops/ webinars for staff and students.
- c) Provide guidance and help wherever possible to BNBCS in its academic and environmental requirements.
- d) Organize E-waste collection and disposal drives.

## 3. Proposed modes of collaboration:

E-Incarnation Recycling Private Limited, (EIRPL) a company registered under the Companies Act 1956 and having its corporate office at 1304 LodhaSupremus, Senapati Bapat Marg, Lower Parel (West), Mumbai 400013 and VPM's B.N. Bandodkar College of Science agree to collaborate with each other for collection drive and proper disposal of E-waste collected during the drive.

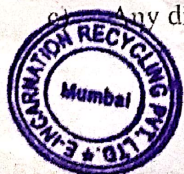
EIRPL is registered as an approved E-waste recycler by the Maharashtra Pollution Control Board (MPCB) under Section 25 of the Water (Prevention & Control of Pollution) Act, 1974 & under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and has an authorization under Rule 5 of the Hazardous Wastes (Management, Handling & Trans-boundary Movement) Rules 2008 and E- Waste and has the facility to complete environment friendly recycling of electronic and electrical components.

BNBCS and EIRPL jointly propose to collaborate through the following:

- a) BNBCS proposes to organize E waste collection drives and collect E waste from students and citizens through such drive once a year in the college, in consultation with EIRPL
- b) BNBCS proposes to hand over the E Waste collected by its volunteers to EIRPL.
- c) EIRPL would collect the E Waste from BNBCS collection site at earliest possible date, within a week of conclusion of the E Waste collection drive and transport it for disposal to EIRPL site. Cost of transportation would be borne by EIRPL. Permissions, licences etc if required for collection and transportation of the E-Wastes would be obtained by EIRPL.
- d) EIRPL would dispose the collected E Waste in a manner safe to the environment. Any data/ information in the collected E waste would be effectively erased by EIRPL.
- e) EIRPL would provide a certificate to BNBCS mentioning collection of the E-Waste and the quantity of E-waste weight collected, within 7-21 days of pick up.
- f) EIRPL would provide a certificate to BNBCS a certificate of data destruction against all the data storage devices received, confirming that data has been safely destroyed.

## 4. Terms and Conditions:

- a) This MoU may be amended, renewed and terminated by mutual written agreement of the Institutes at any time.
- b) Either institution shall have the right to terminate this MoU upon 60 days prior written notice to the other institute.
- c) Any disagreements would be amicably settled between the MoU partners.



5. **Confidentiality:**

- a) The Institutes agree to hold in confidence all information/data designated by the Institutes as being confidential which is obtained from either Institution or created during the performance of the MoU and will not disclose the same to any third party without written consent of the other Institution.
- b) The above confidential clause under this MoU excludes the information/data possessed by either Institution before entering into the MoU or independently developed and/or information already available through public domain.




6. **Duration of MoU:** This MOU, unless extended by mutual written consent of the Institutions, shall expire in **Two Years** after the effective date specified in the opening paragraph. However, on review, the MOU shall be extended by mutual consent.

7. **Coordinators:** Both Institutes will designate persons who will have responsibility for co-ordination and implementation of this agreement.

8. **Signed in Duplicate:** This MoU is executed in duplicate with each copy being an official version and having equal validity. By signing below, the Institutes, acting by their duly authorized officers, have caused this Memorandum of Understanding to be executed, effective as of the day and year first above written.
