Agenda 1: To read and confirm minutes of the last meeting held on 16th August 2024

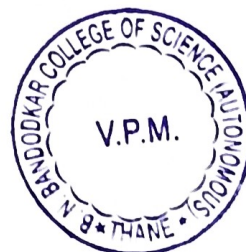

Agenda 2: Syllabus of T.Y.B.Sc. revised under NEP 2020

Syllabi of T.Y.B.Sc. revised under NEP 2020 in the subjects of Botany, Chemistry, Biochemistry, Statistics, Microbiology to be implemented from academic year 2025-2026 were presented to the members of Governing Body. I/C Principal informed about dates of declaration of results of FYBSc Semester II, SYBSc Semester IV, TYBSc Semester VI, MSc. Result printing works are currently under progress.

Agenda 5: Any other matter

1. I/C Principal Dr. Vinda Manjramkar discussed issue of students having ATKT at FYBSc as well as at SYBSc. Such students are not allowed to take admission for TYBSc. However under Autonomy we can allow such students to continue their third year of graduation but results of Semester VI will not be declared till they clear their all the backlog. Members of Governing Body asked about the need and legality of proposed admissions at TYBSc. I/C Principal informed about poor awareness of students in identifying whether the candidate is failed in internal or theory or Practicals. These students if take a gap of a year, joins some jobs. It results into dropdown or going away from education system. If allowed, they can continue Third Year and being in college may try to complete the backlog under the guidance of teachers. Governing Body members allowed for the proposed admissions. However asked to check the legality of the decision.
2. I/C Principal madam informed Governing Body members about selection of Dr. Anita Goswami-Giri madam as Principal of ICL Jhunjhunwala College, Vashi. All members congratulated Dr. Anita madam and wished Best Luck for the new opportunity.
